Rentals are allocated on a first-come, first-served basis. Reservations are confirmed upon full payment, and no rental will be held without payment. Availability is not guaranteed until the booking process is completed.

Cancellations and modifications are subject to the standard rental agreement. In the event of overlapping requests, priority will be given to the first completed reservation.

All rental fees are to be paid in full on the booking day.

Pool rental must be closed down with lights off and doors lock no later than 9pm or time of rental agreement.

We encourage a facility walk through with us to get familiar with lay out and to inspect for any pervious property damage. Please make a mental note of all emergency exits and locations of fire extinguishers. For any non-threatening events such as a water leak or a power failure, please call **573-325-3313** or **325-207-1822** (Park Director) any time. For all major emergencies please call **911** then please call park director.

Private pool rentals: PLEASE INITIAL EACH STATEMENT

Pool rentals are available from 7-9 on Monday, 5-7 / 7-9 Tuesday-Sunday. The facility IS NOT
available for access or setup prior to the designated rental period.
Maximum occupancy is limited to 150 people regardless if swimming or not. The number of people
allowed is based off the number of lifeguards on duty.
Once your party has begun there will be no refunds unless of an inclement weather situation.
ALCOHOL IS PROHIBITED ON THE PREMISES FOR RENTALS INVOLVING THE USE OF SWIMMING
POOL. FAILURE TO COMPLY WITH THIS MAY RESULT IN TERMINATION OF THE EVENT AND LAW
ENFORCEMENT BEING NOTIFIED.
LESSEE will be financially liable for all damages to the premises that occur during the period of
lease.
The LESSEE shall not undertake any alterations of any nature on the leased premises.
Scurry County Pool reserves the right to regulate the erection or posting of signs on the premises.
LESSEE shall not assign, sublet, mortgage, or pledge this lease, nor let the whole or any part of the premises described above.
LESSEE agrees to restore the premises to a degree of order and cleanliness acceptable to the Scurry
County Pool
LESSEE agrees that his/her occupancy shall be conducted in such a manner as to not create any nuisance nor interfere with, annoy or disturb neighbors.

PRIVATE POOL PARTY FAQ'S and HELPFUL INFORMATION

- 1. **May we bring in food, drink, cake etc.?** YES, you may bring in any outside food or beverage as long as there are no alcohol or glass containers.
- 2. **Are there electrical outlets, BBQ pits and tables to use?** YES, there are several electrical outlets for use. Additionally, there are standard pool furniture available for your party; please bring additional chairs and tables if you feel they are necessary. BBQ pits are not supplied but are allowed outside pool fence area only.

- 3. Can we decorate for the party? YES, please feel free to bring in tablecloths, streamers and table decorations. We ask that NO balloons be used inside the pool area. Pinatas may be used in the small park (Kiddy Park) located by the splashpad. Confetti is prohibited in pool area.
- 4. **Are pool floats and games allowed?** YES, pool toys are allowed at <u>THE DISCRETION OF THE</u>
 <u>LIFEGUARDS.</u> Games and large floats that interfere with the vision / sightline of a guard will not be allowed.
- 5. **May we enter early to setup for our party?** No, setup may not take place until the rental period begins.
- 6. **Can we hire a DJ for our party?** Yes, a DJ is allowed as long as the volume is kept at a reasonable level. The Pool Manager will make a determination if the noise is an issue.
- 7. What is not allowed at the pool? For the safety and enjoyment of all in attendance, we do not allow alcohol, smoking, chewing gum, glass containers, cut-off denim shorts for swimming, portable BBQ grills or tiki torches. - ** An adult will accompany a child in the zero-entry area of the pool AT ALL TIMES. Additionally, a child or non-swimmer in the large area of the pool will also have to be accompanied by a parent or guardian age 16 years old or older. While we allow non-swimmers to wear floaties and life jackets while in the pool, there should still be supervision from a responsible party. Children that must wear floaties or life jackets are not allowed to go down slide because risks that can occur. Parents are not allowed to hold children and go down slide. Children must be 48" tall and abide by lifeguard rules prior to going down slide.
- ** It is the responsibility of the party host to discard of all trash and clean up after the party. The lifeguards will rearrange the furniture. The deposit of \$100.00 will be returned if the facility is left in an acceptable condition.
- ** When you arrive for your party, the head lifeguard will make contact with you. During your event, please remember that the <u>LIFEGUARDS ARE IN CHARGE AT ALL TIMES</u>. All daily pool rules must be followed during private pool parties as well. Do not hesitate to contact any member of the pool staff for questions or concerns that arise during your event.

Failure to follow any of the mentioned requirements, stipulations, or cleaning will result in a loss of deposit and a ban from any future bookings of the parks facilities.
