Pre-trial motions filed in accordance with Article 28.01 of the Texas Code of Criminal Procedure will be heard immediately following the docket call or they will be specially set for a hearing.

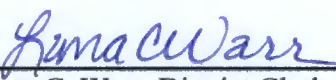
