Pre-trial motions filed in accordance with Article 28.01 of the Texas Code of Criminal Procedure will be heard immediately following the docket call or they will be specially set for a hearing.

Pleas of guilty should be announced at the docket call or before such date; attorneys announcing "ready" should expect to have any offers on a plea of guilty withdrawn after the docket call or at the latest by the plea deadline on **FRIDAY, MAY 16, 2025 at 12:00 p.m.**

Your strict compliance with Article 28.01, Tex. C.C.P., and this notice will insure that a jury will not be called unnecessarily. Your cooperation in this regard will be appreciated.
