

Notice About 2026 Tax Rates

Property Tax Rates in Scurry County.

This notice concerns the 2026 property tax rates for Scurry County.

This notice provides information about two tax rates used in adopting the current tax year’s tax rate. The no-new-revenue tax rate would impose the same amount of taxes as last year if you compare properties taxed in both years. In most cases, the voter-approval tax rate is the highest tax rate a taxing unit can adopt without holding an election. In each case, these rates are calculated by dividing the total amount of taxes by the current taxable value with adjustments as required by state law. The rates are given per \$100 of property value.

This year’s no-new-revenue tax rate \$0.7784/\$100.

This year’s voter-approval tax rate \$0.8617/\$100.

Unencumbered Fund Balances.

The following estimated balances will be left in the taxing unit’s accounts at the end of the fiscal year. These balances are not encumbered by corresponding debt obligation.

Voter-Approval Tax Rate Adjustments

State Criminal Justice Mandate

The Scurry County Auditor certifies that Scurry County has spent \$1,251,426 in the previous 12 months for the maintenance and operations cost of keeping inmates sentenced to the Texas Department of Criminal Justice. Scurry County Sheriff has provided Scurry information on these costs, minus the state revenues received for the reimbursement of such costs. This increased the voter-approval tax rate by 0.0248 /\$100.

Indigent Health Care Compensation Expenditures

The Scurry spent \$267,767 from July 1 2025 to June 30 2026 on indigent health care compensation procedures at the increased minimum eligibility standards, less the amount of state assistance. For current tax year, the amount of increase above last year’s enhanced indigent health care expenditures is \$25,428. This increased the voter-approval tax rate by 0.0010 /\$100.

Indigent Defense Compensation Expenditures

The Scurry spent \$243,951 from July 1 2025 to June 30 2026 to provide appointed counsel for indigent individuals, less the amount of state grants received by the county. In the preceding year, the county spent \$240,538 for indigent defense compensation expenditures. The amount of increase above last year's indigent defense expenditures is \$3,413. This increased the voter-approval tax rate by 0.0001/\$100 to recoup .0001.

The 86th Texas Legislature modified the manner in which the voter-approval tax rate is calculated to limit the rate of growth of property taxes in the state.
