Pleas of guilty should be announced at the docket call or before such date; attorneys announcing "ready" should expect to have any offers on a plea of guilty withdrawn after the docket call.

Your strict compliance with Article 28.01, Tex. C.C.P., and this notice will insure that a jury will not be called unnecessarily. Your cooperation in this regard will be appreciated.
